WHEREAS, the voters of the Quogue UFSD approved the proposed General Fund budget of \$9,455,999 for the fiscal year 2021/2022 at the Annual District meeting held on May 18, 2021;and

WHEREAS, revenues in the total amount of \$1,488,095 are projected from other sources.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education authorizes a tax levy on the total taxable assessment value of \$4,290,728,248 in the amount of \$8,007,904 for school purposes;

AND, BE IT FURTHER RESOLVED that the Board of Education authorizes a tax levy in the amount of \$1,043,195 to be raised for the Quogue Library for the Quogue Library Operating Fund;

AND, BE IT FURTHER RESOLVED that the total amount of taxes for these purposes is \$9,051,099.
